#### Step Seven is a Conclusion

My Creator, I am now willing that you should have all of me, good and bad. I pray that you now remove from me every single defect of character which stands in the way of my usefulness to you and my fellows. Grant me strength, as I go out from here, to do your bidding. Amen. —Seventh Step Prayer

There was true humility and deep surrender by asking God to *take all* of me—both the "*good*" and the "*bad*." This was an admission that I could not trust myself to differentiate between the two.

I almost drank after five months of sobriety before going into the 12-Step process with my sponsor. He wisely pointed out the obvious fact that my mind lied to me. It was not to be trusted! I needed a Higher Power (God) to see the truth about myself. What an egoshattering revelation! Yet, it was necessary to give up on myself and trust God to take over my recovery.



It is said that, "Self cannot rid self of self with self."

In Step Three, I had asked God to remove the "bondage of self" with only a scant idea of what that was. But Steps Four and Five provided a better view of my defects of character and shortcomings. (Bill W. stated these words were to be used simultaneously or in the same context—please note Step Seven on page 59 in the Big Book uses the word "shortcomings" rather than "defects of character," as in the prayer above).

It is important to notice that the Seventh Step prayer ends with the word "*Amen*." Meaning *so be it*, this indicates a conclusion. However, there is no "*Amen*" following the Third Step Prayer, or those in Steps Four, Five and Six! Why?

I think it's because <u>Step Seven</u> concludes a process: In Step Three we ask to be relieved of the bondage of self, but we don't know what that is until we do Steps Four and Five. By Step Seven we know more precisely what we are asking God to remove from us as we go out to do His bidding. The process has been concluded; however, more will be revealed.

#### A.A's In The Know

Is it a "meeting" or a "group"?

A.A. groups are defined in the long form of our Third Tradition. However, some A.A. members hold A.A. "meetings," which differ from the common understanding of what a "group" is. These members simply gather at a set time and place for a meeting for convenience or some special situation. The main difference between meetings and groups is that A.A. groups continue to exist outside the prescribed meeting hour, ready to provide Twelfth Step help when needed.

Also, A.A. Groups are registered with the General Service Office in New York as well as their local Intergroup, District, and Area. —The A.A. Group pamphlet, p. 12-13

### **Step SEVEN**



Humbly asked Him to remove our shortcomings.

Although Steps 6 & 7 are the shortest Steps in terms of wording in our Big Book, they are probably the most potent of all twelve. As we mentioned in Step 6, they **ARE** the meat & substance of our program of recovery. They embody the miracle of transformation as we turn over our broken, defective personalities for God to transform them into healthy, effective instruments of God's will.

One of the first and most important things we need to learn about our defects is that we can't be relieved of them without some level of humility. Alcoholics are victims of pride and selfishness. In the past when we felt pain and suffering (generally as a **result** of said pride & selfishness), we masked it with alcohol. Before coming to A.A., we used self-reliance to deal with it. Today, we can acknowledge the limits of human power in addressing these character defects. We cannot do it on our own. We cannot do it by sheer willpower. We cannot do it by our own intellect and reasoning.

#### **Myths About This Step**

- 1. **Humility isn't necessary for recovery.** You can't see your shortcomings without stripping yourself of your ego and pride. This unfiltered look into yourself allows you to develop a humble attitude and correct your moral defects.
- 2. Step 7 means we will not have any defects once God removes them. Self-centered fear will still trigger our defects. The difference is that we now have a choice to follow our lust, for example, or not. We will be given a divine nudge at the onset of our defects to pray to God to change us, and God will, whereas, before Steps 6 & 7 we had no choice over our defects and were obsessed by them.
- 3. We have the ability to remove our defects ourselves. This sort of thing is WAY above our pay grade. We simply don't have the builtin skill sets to become less prideful, angry, greedy, gluttonous, lustful, envious, slothful or fearful on our own.

#### <u>Concept VII</u> (Long Form)

The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

#### In Other Words:

The Board can override the Conference when necessary.

The charter and bylaws of the General Service Board (GSB) ARE legal documents. The charter of the <u>General Service Conference</u> (GSC) IS NOT. Period!

Because of that, there may be times where the <u>Conference</u> has, shall we say, gone off the deep end, and the Trustees (legally or otherwise) need to reel them back in through the vetoing of a <u>Conference</u> action.

The Trustees have "legal authority," where the <u>Conference</u> only has "moral authority".

#### **TRADITION Seven (Long Form)**

"The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then, too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority." Note: Read the history of Washingtonians, an early, vital group successful in getting many people sober and why they eventually failed!

Twelfth Step work is the lifeblood of Alcoholics Anonymous — carrying the message to the next suffering alcoholic. Without it, the Fellowship would wither and die. Yet, even at its simplest level this vital contact between one alcoholic and another involves an investment of time and money. The paradox of A.A. is that financial independence and the support of our Fellowship by alcoholics and alcoholics alone not only enhances A.A.'s importance to each of us, but stimulates our engagement in our own recovery.

#### 7<sup>th</sup> Tradition ~ F.A.Q.'s

Bank Accounts and Tax ID Numbers

Question: Our group needs to open a bank account and was asked for an "I.D. number". How do we obtain an I.D. number for our group checking account? Can we use SEPIA's?

Answer: More and more frequently, A.A. groups in the U.S. are being asked to supply an I.D. number to a bank when opening a checking or savings account, whether or not it is interest-bearing.

All local entities, which includes A.A. groups, must obtain their own Employer Identification Number (EIN) from the IRS. You cannot use any one else's.

To get this number, fill out IRS Form SS-4, Application for Employer Identification Number, available at <u>www.irs.gov</u>. This number applies even though the group is not an employer.

Look for the section about obtaining an EIN for banking purposes only. The form asks if there is one group exemption number that applies to all—there is not.

The Al-anon speaker was a long-timer based on her presence in the countdown. She gave a particularly emotional talk about her home group, Al-anon Monday Night, which meets on Monday nights at 4021. The group recently lost its second co-founder when Mary R. passed away this year.

Recently the 4021 University group celebrated their anniversary. The Young Peoples' group has a rich history available at SEPIA archives, being, as far as we know, the first young peoples' meeting and convention. *Note: The Young People's Group is having an Alka-thon on July 4<sup>th</sup>; please see the flyer attached to this Interviews newsletter.* 

The 4021 Club itself has a rich history which began in 1946. Conor F., who was the founder of A.A. in Ireland, was one of the 17 people who donated \$100 each to the mortgage for this property. Conor was a Philadelphian, who when newly sober, took a vacation in Dublin, taking his wife, his Big Book, and "can-openers" (A.A. pamphlets) with him. Desperate for fellowship while there, he searched for a drunk to help until he located one, and so A.A. in Ireland began.

Remember when you knew you wanted sobriety and you found that it was available to you? Perhaps you had fun at the Saturday night dances, found inspiration at the Sunday Morning groups, or learned more at the Bookers meetings with Chester County's Red Fox group. OUR TWELVE TRADITIONS AA members share their own stories of experience

#### Excerpts on the Seventh Tradition from Our Twelve Traditions:

"AA not only saved my life, but changed it for the better. My sobriety is worth more than I can pay. When the basket comes around, do I give generously or do I find reasons to hold back? When I came to AA, I attended 10 meetings a week for the first year. That meant I was contributing at least \$10 a week. Now I may attend two to three meetings a week, but instead of just two to three dollars a week, I should still be putting in at least \$10, if not more.

So when someone says the coffee is free, think about what that statement means, and think about what sobriety is worth to you."

"I am probably not the only "alkie" to come to the Fellowship with a protective coat of cynicism, particularly regarding money. When I heard the Traditions and the words from the Preamble about being "selfsupporting through our own contributions," I thought, "Yeah right."

That attitude was erased when I heard my first treasurer's report. (I'd become teachable in the intervening months.) It was delivered by a gravel-voiced man named L.A. He got right to the point: "We had more than \$75, so we gave the rest away." I didn't hear another word of his report. My head was racing with the thought, Now here's a group of 30 or 35 people, pretty much all of whom donate a dollar each week. And when they get more than \$75, they give the rest away! And this guy sounds like he's proud of it! I didn't need to hear any more; I'd gotten the message I needed: Nobody's in this thing for the money."

# THIS MONTH IN A.A. HISTORY \*\*\* JULY \*\*\*

- July, 1962—"Victor E." cartoon first appeared in the AA Grapevine.
- July 2, 1960—Father Ed Dowling, Jesuit priest and spiritual advisor to Bill W., died. After seeking out Bill W. in early 1940 because he had noticed similarities in the Twelve Steps to the Spiritual Exercises of Ignatius of Loyola, a friendship was born. Dowling directed many alcoholics to A.A., and by the summer of 1940, Dowling's native St. Louis had its own A.A. chapter.
- July 2, 2000: 20 millionth copy of the Big Book was given to Al-anon in Minneapolis, MN.




• July 2-4, 1965—Ten thousand people attended *Victor E.* the 30th Anniversary of A.A., held in Toronto. The Responsibility Declaration, which begins "I am Responsible", was adopted.

• July 4, 1940—Bill D. (A.A. #3) checked out of City Hospital in Akron, OH after hearing the message from Bill W. and Dr. Bob. With the addition of Bill D., A.A'.s first group was formed. Bill D. never drank again.

• July 7,1940—Bill W. attended the first summer session at School of Alcohol Studies at Yale University.

- July 14, 1939—Blythewood Sanitarium (Greenwich, CT): Dr. Harry Tiebout gave a Big Book to Marty M., who promptly threw it back at him. Eventually she read it and took its suggestions to heart, becoming one of the first women to get sober in A.A. She would go on to found the National Council on Alcoholism and Drug Dependency (NCADD) to educate others on alcoholism.
- July 14, 1979—Dr. Ernest Kurtz publishes *Not God*, a history of early A.A. which also probed the philosophical and theological ideas behind the movement. The book is still in print today.
- July 22, 1877—Willian Duncan "Silkie" Silkworth, Bill W.'s doctor and author of *The Doctor's Opinion*, was born in Brooklyn, NY.
- July 22, 1980—Marty M. one of the first women in A.A. (see above), died.
- July 23, 1940—Philadelphia A.A.'s sent 10% of their collections to the Alcoholic Foundation (later to become A.A. World Services), setting a precedent.
- July 28-30, 1950—The first A.A. International Convention was held in Cleveland, OH. The Twelve Traditions were adopted. Dr. Bob made his last appearance at a large A.A. gathering there.
- July 31, 1972—Rollie H., former baseball player and one of the first A.A.'s to break anonymity at a public level (radio), leading to a renewed emphasis on the importance of anonymity, died sober in Washington D.C.


