# A MEMBER SHARES...

## It Was a Miracle

I think I was predestined to become an alcoholic. I say this in hindsight. Here is why.

The first time I got sick drinking I was five or six. The men were drinking beer and playing cards at the dining room table. As they deposited the bottles into the case I picked them up and drained them. Somebody put a cigarette butt in one. Oh yeah, I downed it. I got very sick. It didn't stop me from drinking and smoking.

The first resentment I had about being cut off from a drink was in 7th grade. Grandad was giving us full glasses of homemade wine with a little 7-Up. I couldn't have a second one because one of the cousins got drunk on the first! I was not happy.

In 8th grade I went out with the guys, four or five of us, with a gallon of wine. I couldn't understand how the others were getting drunk. I wasn't. In high school Freshman year I began drinking every Friday and Saturday. I was drinking almost every day by the time I graduated. I had a lot of blackouts. I thought everyone did. Most of my friends got hangovers. I did not.

In college mini-fridge held about 16 quarts of beer and that would hold me until Friday afternoon. I would drink and pass out two or three times on Fridays and Saturdays. I became associated with many of the antics at the school—even some I had nothing to do with. I wasn't allowed to return the second semester.

## **Concept VIII** (Long Form)

Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning and safety. The primary world service leadership once exercised by the founders of A.A. must necessarily be assumed by the Trustees of the General Service Board of Alcoholics Anonymous.

#### In other words: We lead to serve rather than leading to govern.

As we study the Concepts, the ninth change that is taking place in us is that we understand we must become selfless leaders.

What are the changes that need to take place in our lives in the Ninth Concept in order to serve as good leaders? We need to surrender old ideas about leadership and be willing to put aside any personal ambitions, feuds, and controversies that prevent us from offering effective leadership.

We need to become a spiritual example, someone who can personally put principles, plans, and policies into such dedicated and effective action that others want to back us up and help us with our job.

So I started Junior College. I was living at home. I began closing bars, and going to all-night bars before I was even of legal age to drink. It wasn't uncommon for me to miss a class or work because I was still passed out. That night I would be fit enough to do it again

I started trying to manage my drinking in my twenties. No hard liquor, only wine after work, trying different brands. I left school and went to work in the family business. This was great for me. I could drink during the day, shower, then go out after work and drink some more. I was having fun. I met my first wife then. She had concerns about my drinking. I adjusted it and hid it. I must have done a good job because we were married in '73. I was back to myself in short order. Th drinking progressed. I had more and longer blackouts. In one blackout I fired my entire company, over twenty people. I found out the next day when nobody showed up for work! I stayed successful in my business, however, because I was buffered behind some really good employees. In fact, my business flourished. So did my drinking.

All this "greatness" lead me to continually think about ending it all. The thought was there to just vanish to skid row and drink cheap wine. I wondered how long I could last with a set amount of money. But I had no thought about stopping my drinking.

My last drunk lasted about nine months as best as I can piece tougher. I was in a blackout for most of it. I can remember bits and pieces during that time without much continuity. There were car wrecks, arguments, fights, sordid events, all of it. Wanting to die daily, only to wake up the next day wondering what happened, and disappointed to be waking up. The last day I drank was on a Sunday. I left for a pack of cigarettes around noon. Don't know



what time I returned. The house was dark and all were asleep. The next morning found me remorseful and confused. What was I to do? Who could help me? I had no idea! But I told my wife not to worry.

She glared at me with fire in her eyes. "What are you going to do?"

Instantly I replied, "I am going to call A.A."

She became silent as did I. Where in the world did that come from? Later in the day, I called A.A. I knew they had meetings about not drinking. A member named "Drill Sergeant" Harry called me back. I argued with him about picking me up because I didn't want to drive—I was afraid my truck might automatically pull into one of the many bars *en route*. Harry gave me the address to someone's home. I showed up! I understand now that an "Act of Providence" was already working in my life. I got socially active with the clubhouse in our area. I sat on my hands for months and watched others go back to drinking and never have the ability to return. With quiet desperation I kept going to meetings. I wondered when it would be my turn.

I really worked Step Three when I went on a retreat. I was there to complete Step Four and I could not list anything of value. I turned it over and asked Him for help. Oh, did I write! My sponsor was to hear my Fifth Step there. He did not show. I did my Fifth with another member of my Thursday night group. I fired my sponsor and chose another. The man I chose to be my sponsor lived the Big Book. I am grateful to him and the old-timers! My sponsor took me through the rest of the Steps. He did much more than that, too. The list that I created earlier has had all amends completed except for a few life-long that will be in process until I pass. When I do recognize those I tend to them as soon as possible. Continued reflection on my life has helped me to grow. I can look around today, at the past, and where I intend to go in the future.

I feel the great testimony to any of our lives is not in what we do. It is in who we become and who we help because of who we are today. May the Spirit of the Universe guide and protect you from the very moment you believe you can use the help of Alcoholics Anonymous. That's what happened to me. -Pez

#### **Step Nine**

Made direct amends to such people wherever possible except when to do so would injure them or others.

Step Nine is about taking action and making amends through first identifying hurt or harm caused and then finding out how we can make it right to those we've have harmed with our drinking and our thinking.

Remember: It's not about saying "I'm sorry."

This step will provide us with peace of mind, relief, and liberation from the chains of regret. "The readiness to take the full consequences of our past acts, and to take responsibility for the well-being of others at the same time, is the very spirit of Step Nine." (Twelve Steps and Twelve Traditions., p. 87).

That said, it also says on the top of page 77 in the Big Book that the "real purpose is to fit ourselves to be of maximum service to God and the people about us."

The choice is ours... Do we want more of what brought us to A.A.? "We were having trouble with personal relationships, we couldn't control our emotional natures, we were a prey to misery and depression, we couldn't make a living, we had a feeling of uselessness, we were full of fear, we were unhappy, we couldn't seem to be of real help to other people…" (Big Book, p.52). **OR** do we want freedom from the bondage of the flaws in our character that caused our failures in the first place?

## **TRADITION NINE (Long Form)**

Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our overall public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

# Overriding Idea of T9: Organization and Service Aren't Mutually Exclusive

In the beginning, our founders really felt like we didn't need much organization and structure in the Fellowship, and then they went and created a bunch of it.

One of the best examples of this is if you reach out to the General Service Office (GSO) for their ideas on a specific issue that your group, District or Area may be having, you can be relatively sure that the response

will start off with something like, "That's a great question. Our shared experience in A.A. is...." Then they will offer suggestions of solutions from those that have gone before us to help you with your concern. They cannot tell us what to do, but they can help us.

The organization of our Fellowship is crucial to our being able to carry the message to the still suffering alcoholic, but that structure is not there to govern, but to serve.





# THIS MONTH IN A.A. HISTORY

# \*\*\* SEPTEMBER \*\*\*

- September 13, 1937—Florence R., the first female member of A.A. in New York, get sober. Read more about her below.
- September 17, 1954—Bill D. (a.k.a "A.A. #3"), who was the first person to successfully get sober after hearing the message carried by Bill W. and Dr. Bob, dies in Akron, Ohio. He had 19 years of continuous sobriety.
- September 21, 1938—Bill W. & Hank P. form Works Publishing Company in order to raise money to finance writing and printing the Big Book.
- September 24, 1940—Bill W. twelve-steps Bobbie B., the "forgotten fantastic communicator", who would replace Ruth Hock as National Secretary of A.A. HQ. (Later A.A. World Services).
- September 28, 2001—The Ground Zero Group, which formed across the street from the fallen towers of the World Trade Center, opened to firefighters, police, steelworkers, medics, and others clearing the debris from the site. The room was open around the clock, and many of its visitors were from out of town. It closed its doors at the end of November, 2001.



 Unknown date in September,1930: Bill W. wrote his fourth (and last) promise in his family Bible to quit drinking. He would proceed to drink for four more years until his fateful trip to Towns Hospital in December, 1934 where he would have a spiritual awakening and finally stay sober.

#### Female Pioneers of A.A.

Florence R. was the first woman to get sober in A.A. Her journey started in March of 1937 when Lois W., wife of Bill W., came to visit her at the hospital at the request of a mutual friend. Lois told her about A.A., which was less than two years old at the time. At the time, alcoholism was thought as something that only affected men, and as bad the stigma against male alcoholics was in the 30's, it was even worse for women. Admitting that she had a problem with alcohol could ruin a woman's reputation for life. It must have taken great courage—or great desperation—for Florence to walk into that first meeting where the only other women around were the wives of alcoholics.

At first Florence experienced several "slips", as they called them then, but was sober over a year when she wrote her story for the first edition of the Big Book: A Feminine Victory. She prayed for the inspiration to tell her story in such a manner that would give other women courage to seek the help that she had been given. Florence's membership in A.A. was the reason the suggested title 100 Men for the Big Book, which was published in 1939, was rejected. She moved to Washington, D.C. and helped start A.A. there. She married an alcoholic who unfortunately did not get sober. Eventually, Florence started drinking again as well, and disappeared from history. Despite her relapse and eventual death from alcoholism, Florence's early presence in A.A. helped pave the way for the many women that followed.

In A Feminine Victory, Florence wrote: Coming to the grim fact of alcoholism, I wish I could present the awful reality of its insidiousness in such a way that no one could ever again fail to recognize the comfortable, easy steps that lead down to the edge of the precipice, and show how those steps suddenly disappeared when the great gulf yawned before me. I couldn't possibly turn and get back to solid earth again that way.




